Terms & Conditions

1. Deliveries & Unloading

- A. Delivery is to curb only, we will make every effort to place your product where you request. We are not responsible for broken curbs, side walks, driveway, power wires, phone lines, sprinklers, trees, retaining walls, ETC. or any other damage.
- B. Delivered items will not be placed inside the curb line unless responsibility is assumed, in writing, by the Contractor or Property Owner and then only at the discretion of our driver.
- C. If rain has fallen, all delivery orders will be sent unless canceled by the Buyer.
- D. If requested, we will make an effort to provide a courtesy call prior to delivery. Delivery of materials will still occur whether or not contact is made.

2. Quality & Claims

- A. Bedrock Boulders and Landscape Products, products are guaranteed to conform to the specifications currently published at the time of shipment.
- B. It is the responsibility of the Buyer to inspect and approve all units before installation. If the material is regarded as unsatisfactory, a representative of Bedrock Boulders and Landscape Products must inspect the material before installation. Bedrock Boulders and Landscape Products WILL NOT be liable for claims made after installation has occurred.
- C. Stone is a product of nature, as such; we are unable to guarantee the consistency of color, size, quality or availability.

3. Special Orders

- A. Signed Purchase Orders are required for special shapes, colors, textures, and strength units provided by Bedrock Boulders and Landscape Products. Buyer shall be responsible for all items on the Purchase Order. Payment for special order units is due upon placement of the order.
- B. Purchase Order quantities must be supplied by the customer. Bedrock Boulders and Landscape Products does not have control over construction methods or job changes, therefore is not responsible for the accuracy of estimates of the customer.

4. Quotations

Written quotations will be honored for (30) days from the date of quotation.

5. Pallets

A deposit will be charged for all wooden pallets containing block. This deposit will be refunded at \$3.00 less than charged upon return of pallet in good condition with receipt only.

6. Boulder Delivery

Boulder placement is available and is a flat fee of \$60 plus a regular delivery fee (depends on delivery address). The flat boulder placement fee includes 30 minutes of placement time. Any additional time spent placing boulders will be billed at \$60 per half hour. The area must be prepped and ready to have each boulder placed prior to delivery arrival. Bedrock drivers and/or employees WILL NOT prep the area. We will make every effort to place the boulder(s) where requested. In the event that we cannot place the boulder(s), the boulder(s) and delivery fees are NOT REFUNDABLE.
